In 12 months after my death if demanded and I dodisallow and revokeIn witness whereofset my seal this 24th day of Sept. 1772.

I leave to my <u>brother</u>, <u>THOMAS</u>₁, all my horses and cattle and all the little debts that is due me in the neighbourhood and that \$60 that is in my father's hands I allow it to be divided equally between my brothers and sisters that LIVE IN VIRGINIA. Also I leave to my sister-in-law, wife of Thomas Gleaves, my Negro boy GREEN. If he is not redeemed she may keep him during her life and then to remain to her children afterwards only. I allow <u>Brother</u>, <u>ABSALOM</u> \$85 out of his price in good property. Also I allow that land in Kentucky to be sold and the price to be divided equally between my mother and father, sisters and brothers. I allow my <u>cousin</u>, <u>MATHEW Gleaves</u>₄ \$20 out of the price of it also I allow <u>Betsy Smith</u> ten dollars of the price of my big steed(?) paid by Thomas Gleaves. I do renounce and disdain all other wills by me made.

In Augusta County, July 20, 1809.

First: all just debts to be paid after necessary expense of burial.

<u>SECOND</u>: I give to my beloved wife **MARY** during her natural life or widowhood all my slaves and stock of every kind....for her use and disposal during her life or widowhood....also the tract of land whereas I now live together with all the lands adjoining and between said tract & the mountain, to wit, the tract including the Oa____? Bank also my tract of land adjoining the lands of Grover Clemmons and Widow Barrier, George Hagle? And Jacob Koiner....

All furniture & implements of husbandry or farming utensil....nevertheless it is my will personal estate shall be legally appraised.

<u>THIRDLY:...</u>that my <u>wife's mother, Easther Woolman</u> shall have a decent support out of my estate during her natural life or widowhood.

<u>FOURTHLY</u>: I give to my grandson, Thomas Turk McCullough, 200 lbs. to be paid by exec. when he arrives at the age of 21. I also give to my grandson Thomas Turk REAH 100 lbs. To be paid when he arrives at the age of 21....should either grandson not arrive at age 21, the sums devised to them to be equally divided between my daughters, ESTHER JOHNSTON, BETSY COGER, REBECCA ANDERSON & my son JAMES TURK.

<u>FIFTHLY</u>: I give to my wife MARY my Negro boy Harry and Negro girl Charlotte and increase

<u>SIXTHLY</u>: at the death or marriage of my beloved wife, Mary, I give and bequeath to my son JAMES TURK the tract of land whereon I now live together with all the lands adjoining thereto on the east side of the South River,excepting one acre of ground including the grave-yard which except...? Ever being transferred; and to enjoin it upon my son James aforesaid to have the said acre of ground kept well inclosed by a strong pailing.

<u>SEVENTHLY</u>: at the death or marriage of my wife Mary...it is my will that the whole of my estate not before particularly divided as well real as personal shall be sold by my executors...and the money arising from such sale to be equally divided between my children, to wit: Esther Johnson, Betsey Coger, Rebecca Anderson and James.

<u>EIGHTHLY:</u> I give to my daughter, JANE ALLEN, ONE DOLLAR, to my daughter, <u>BETTY GLAVE</u>, one dollar and to my son THOMAS TURK one dollar to them and their heirs forever. <u>LASTLY</u>: appoints my worthy friends, Andrew Ramsey, William Patrick and Robert Porter Field, Executors of my last will.....my hand and seal this 3rd day of Aug. in the year of our Lord 1808.

Item 5th: I give and bequeath 340 acres of land lying in Davidson County on the waters of Whites Creek and 100 acres adjoining Zach. Stu...? In Davidson County to my son, **Michael Glave**₂

Item 6th: I allow each of my <u>single sons</u> that is John Glaves, Michael Glaves₂ and Thomas Glaves₂, as long as they continue living with mother each of them to keep 1 horse of their own and no more.

Item 7th; To my daughter **Isabella Glaves** the gray diameede(?) filley and a Negro girl named Priscilla.

Item 8th: My sons John Glaves, Michael Glaves₂, Thomas Glaves₂ and William Glaves are to pay my daughter Isabella Gleaves each \$200 when her mother may think she should have it. Item 9th: I wish all my stock of cattle to be collected next July and sold upon a credit of not more than 2 yrs nor less than1except 10 cows and 2 or 3 steers I give 1 Negro girl named Jenna to my son, Matthew Gleaves₄. the balance of my Negro slaves to remain in possession of my wife during her life to be under the direction of my Executors Ezekiel B. McCoy, John Davis and William Gleaves.

Witness: William P. Robinson & Jenny Robinson. /s/ Michael Gleaves (seal) Since I assigned the above......find I had forgotten to make provisions for my daughters after the death of my wife I wish my Negroes to be sold except negro boy named Jack which I give to my son Michael Glaves₂ Also a Negro boy named Jesse which I intend for my son Thomas Glaves₂ when it may be convenient for my wife and my above named 2 sons Michael and Thomas Glaves₂ shall think it convenient to separate them, also a little yellow slave named Cynthia which I give to my granddaughter, Rachel Turner – also a small girl 5 yrs. old Ceila by name after the death of my wife my son John Gleaves is to have her and her increase. I give and bequeath to my daughter Elizabeth Turner \$200 dollars in cash to be left in the hands of my executors to be paid to her for her benefit and her children and if she should die before she receives it my executors are to be bound to let her children have \$200 when they are in want of it......money arising from sale of my horses and cattle next fall.....to be equally divided between all my children except one which is Elizabeth Turner. The Truxton colt now a year old I give to my son, Thomas Glaves₂. My blacksmith tools I give to my son John Gleaves. This is my last Will and Testament....13th day of Feb. 1811. signed: Michael Glaves (seal).....Duly proven in open court....upon the oath of William P. Robinson and Jenny Robinson.

I, William Gleaves make my Will

I allow my affectionate **wife ELIZABETH** to live in the house where we now reside during her life & be well supported from the proceeds of the plantation.....I devise to my wife to dispose of as she thinks proper my 2 negroe women, namely LETT and WINNY. I also give to my wife all the balance of my Negroes during her natural life, but she may dispose of them provid she disposes of them as I shall hereafter direct. I also devise to her to dispose of as she thinks proper 1/3 part of all the money that may be on hand and also 1/3 part of all the money that may be due on bonds also one horse saddle & bridle hir choice of all my horses and two beds & furniture hir choice and appearval (approval) I bequeath to my wife Elizabeth the balance of my household and kitchen furniture during hir natural life, and when it is please heaven to call hir hence the property given hir except such as is at hir disprovial shall be devided as hereafter directed.

To my daughter NANCY GLEAVES, I devise my negroe girl Patt & hir 4 children (to wit) Levina, Dicy, Eliza & Harden with the increase of the females also one mare called Trap and his increase & his saddle & bridle, two beds and all their furniture, ten head of cattle (to wit) five cows, 5 head of young cattle, ten head of sheep, though she is not to receive the cattle & sheep during hir single life & not to keep more than 2 head of horses at one time.

To my son, JAMES T. GLEAVES, I bequeath the land whereon I now live with the lands adjoining (to wit) The survey which lies on the south side also Hobbs old place with survey adjoining it, also 150 acres of land which Capt. James Newell Snr. Is to make me a title to, also the tract of land called Wm. Turner's place and also the crab orchard tract of land by him paying to my daughters (to wit): ELIZABETH RAMSEY, MARGARET TURK, ESTHER FINDLEY, SALLY ALLEN & NANCY GLEAVES, 25 POUND EACH AND HE IS TO SUPPORT HIS MOTHER DURING LIFE ALSO HIS SISTER Nancy Gleaves during hir single life, hir not being allowed to keep more than 4 negroes at one time at his expence. I also allow him 4 horses his choice of the horses that may be on the place accept (except) those that I have already disposed of & shall hereafter dispose of. I also allow him 1 wagon and gears & all farming utensils with what plank there may be on hand or anything that may have been purchased for the use of the farm. I also devise to my son JAMES T. GLEAVES 2 negroes namely Sampson & Rachel, one good bed and furniture, 10 head of cattle (to wit) five cows & 5 young cattle, 10 head of sheep and all my hogs.

I wish all the grain & forage on hand or in groth not to be disposed of at the sale but to go to the support of the family

To my Wife Elizabeth in lieu of the horse before mentioned, I bequeath my Yellow mare called Jenny with hir increase.

I appoint my sons, THOMAS, ABSALOM & JAMES T. GLEAVES my executors.

The admin. has produced legal vouchers to the amt. of \$735.08 and one gr. cents together with amt. of expenses of family \$195.00, we do also allow said admin. \$50 as a compensation for his services....making in all \$980.88 \frac{1}{4} leaving a difference in favour of the admin. \$222.63 \frac{1}{4}.

Date: March 23, 1833. John A. Walker and William Wisenor, commissioners apptd. by Court.....now make report of having made settlement which is received and confirmed by the court and ordered to be recorded.

1834 - Negroes divided

The Court of Pleas and Quarter Sessions for Davidson County, empowering us to divide the Negroes Slaves belonging to Estate of Thomas Gleaves: Mariah – valued at \$400; Jes - \$550; Elizabeth - \$400; Duncan - \$100; Harriett - \$250; Prissa - \$250; Rhoda - \$200. Making \$2150.00 and \$49.64 now in the hands of D. McKay altogether amounting to \$2199.64....out of which we allot to Mrs. Mary Gleaves – Mariah and Harriet at \$650 together with \$49.64 – all together \$699.64. upon condition that she relinquish her claim to the balance of the Negroes to

- The Negro boys Jack and Sterling valued at \$560 were allotted to Mrs. Gleaves the widow
- The Negro Alfred valued at \$555.00 was allotted to Sophia T. Young, formerly Sophia T. Gleaves.
- The Negro girl Charlotte and boy Alexander valued \$690 were allotted to J. E. Gleaves:
- Henry and George valued at \$480 was allotted to Jas. W. Gleaves.
- Maria and Tom valued at \$454 were allotted to William D. Gleaves;
- Milly and Rhoda to Sally Gleaves valued at \$700
- while the property advanced to Michael Gleaves was valued at \$814

it being agreed that those who have received property more than their 1 legal share was worth – should contribute to the amount they have received over and above their distributive portion in the equalization of the estate among the several distributive. Therefore it is ordered that J. E. Gleaves pay Mrs. Gleaves the balance due her \$47.57 – The balance due Sophia T. Young, formerly Sophia T. Gleaves which is \$52.57 shall be paid J. E. Gleaves and Sally Gleaves -John E. Gleaves paying \$34.93 and Sally Gleaves the balance due. William D. Gleaves of \$153.57 of which M. H. Gleaves is to pay \$78.93 and the remainder which is \$74.64 is to be discharged by Sally Gleaves thus making the shares or portions of the several claimants equal.

4th......It is my will and I hereby direct that should any one of my above-named daughters die leaving no heir, then it is my will that all of the above property given to the 3 daughters shall go to the two survivors, and if two of them should die leaving no heirs, then it is my will that the survivor become heir of all the above property given to my 3 daughters.

I hereby nominate and appoint B. F. Gleaves⁴⁸ my sole executor of this my last will and testament. Witness my hand this 26th day of Nov. 1865. /s/ James R. Gleaves.

(Note: He died Dec. 9, 1865. He had deeded land to his sons and was trying to care for his 3 unmarried daughters – ages 20, 25 and 31. Three other daughters ⁴⁹ were already married and received nothing. This is what happened to the land: All 3 of the unmarried girls married within about 10 yrs. after his death - in 1873; 1874 and 1876

This was a special (Works Project Admin.) project in the 1930s. All are at the State Library and Archives; they are bound by Counties. There are many typos in them. Probably lots of people who were working on the project were not people who could interpret handwritings, etc. WPA was something similar to "Welfare"....it saved many starving families. It was sometimes referred to as "We Piddle Around". My father didn't think much of it, but I can now see that it was a necessity. At least the people may have "piddled around" but at least they had to get up and go to work, which is something "welfare" doesn't require. The WPA actually built Berry Field - which is now the Nashville Airport.

Gleaves, another Civil War Veteran who lived to be 100 and died in 1945. The Gleaves Cemetery is best known by the name of Clements Cemetery⁵⁰ – called by this name because he had lived there since 1874.
